Purpose

Participants will develop practical legal skills—such as applying relevant laws, analyzing different business structures, understanding incorporation and corporate finance, and identifying legal risks including insolvency and fraudulent behavior. Additionally, the seminar promotes a professional attitude grounded in ethical awareness, regulatory compliance, and corporate responsibility, fostering critical thinking and integrity in legal and business contexts.

This seminar is ideal for professionals across industries who seek a deeper understanding of Corporate and Business Law, especially in areas such as accounting, auditing, taxation, compliance, corporate governance, and contractual liability. It is particularly relevant for accountants, auditors, tax advisors, compliance officers, corporate managers, and legal professionals aiming to navigate complex legal frameworks and make informed decisions that support integrity, risk management, and sustainable business practices
